THIS PARTNER WORKS CLOSELY WITH FAMILIES IDENTIFIED AS "HIGHEST RISK," PROVIDING PRENATAL CARE TO EXPECTANT MOTHERS AND EDUCATING ENTIRE FAMILIES ON THE VALUE OF GIRLS AS HUMAN BEINGS.

THEIR WORK HELPS SHIFT THE CULTURAL MINDSET THAT VIEWS GIRLS AS "BURDENS," CHALLENGING THE PREFERENCE FOR SONS AND PROMOTING AWARENESS OF GIRLS' INHERENT HUMAN RIGHTS. TO SUPPORT THESE FAMILIES, A MONTHLY FOOD RATION (TYPICALLY INCLUDING RICE, LENTILS, AND SPICES) IS PROVIDED TO ENSURE MOTHERS AND DAUGHTERS ARE WELL-NOURISHED. RESCUED BABY GIRLS ARE LATER ENROLLED IN IGP'S CHILD SPONSORSHIP PROGRAM, WHERE THEY RECEIVE ONGOING CARE, EDUCATION, AND SUPPORT.

GIRLS IN OUR CARE THROUGH THE CHILD SPONSORSHIP PROGRAM OFTEN HAVE A REALISTIC CHANCE AT SUCCESS IN LIFE.

THROUGH OUR WORK ACROSS VARIOUS REGIONS IN INDIA, WE HAVE SEEN BOTH ANECDOTAL AND MEASURABLE EVIDENCE - THROUGH STUDIES AND SURVEYS - THAT CHANGE IS HAPPENING. IN ONE COMMUNITY IN SOUTH INDIA, A RESEARCH STUDY REVEALED A SIGNIFICANT SHIFT IN ATTITUDES: OVER FIVE YEARS, THE PERCENTAGE OF GIRLS ENROLLED IN SCHOOL ROSE FROM ABOUT 30% TO NEARLY 90%.
